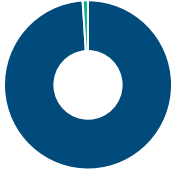

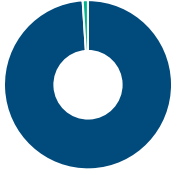

SECTOR ALLOCATION

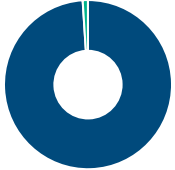

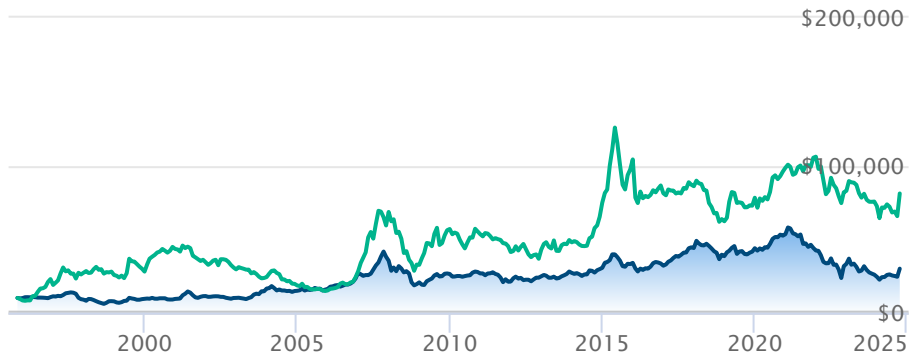
