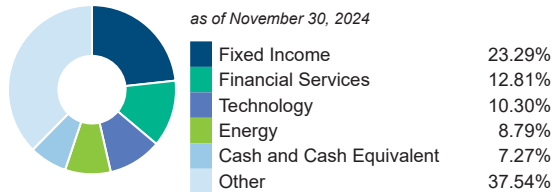
ASSET ALLOCATION

as of November 30, 2024



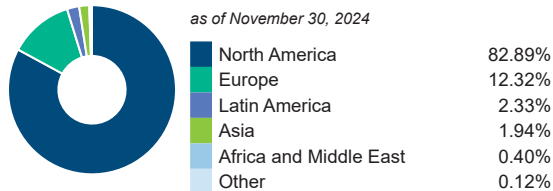
SECTOR ALLOCATION

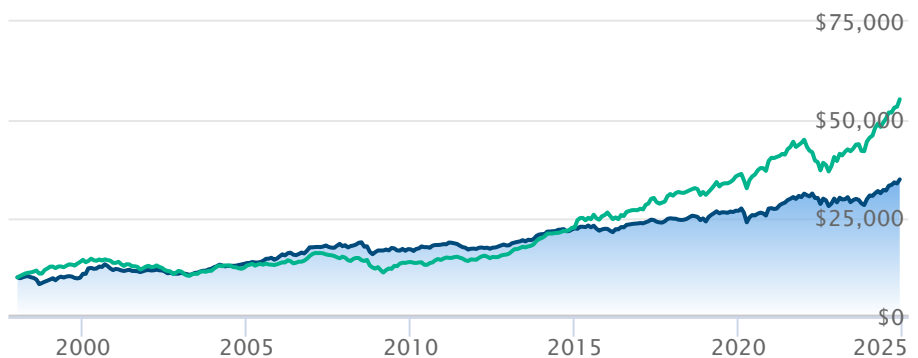
