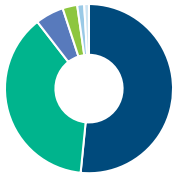

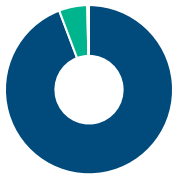

SECTOR ALLOCATION

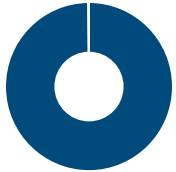

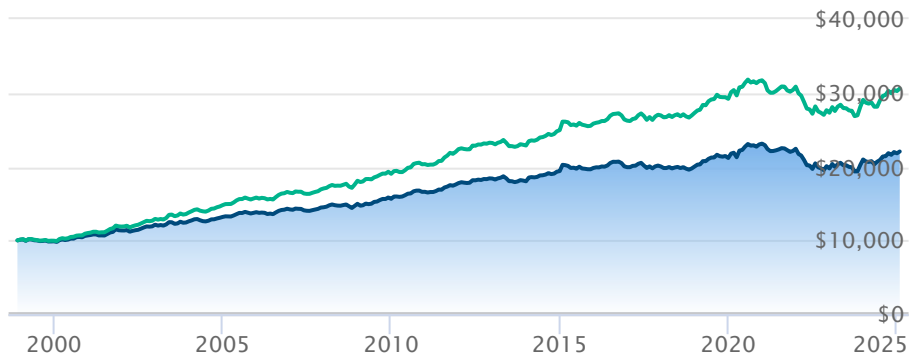
