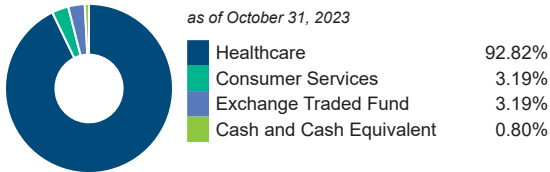
**ASSET ALLOCATION**

as of October 31, 2023



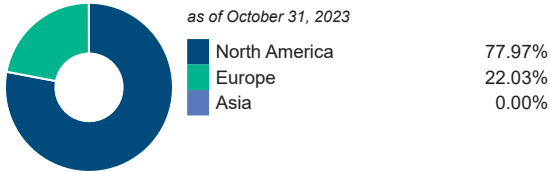
**SECTOR ALLOCATION**

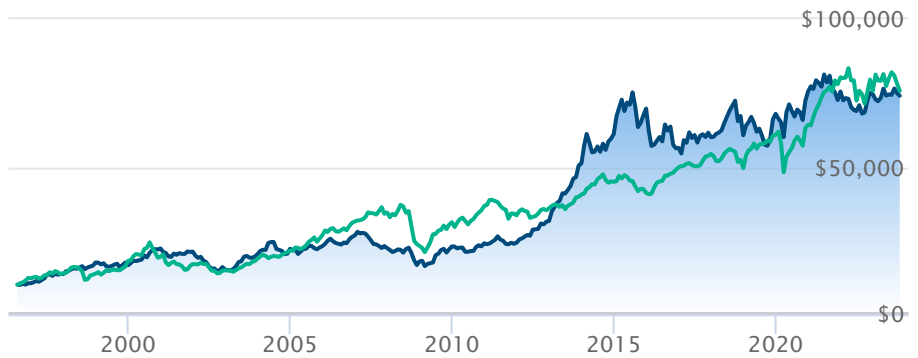
