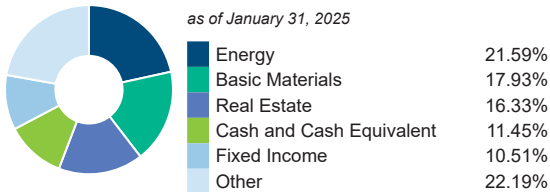
ASSET ALLOCATION

as of January 31, 2025



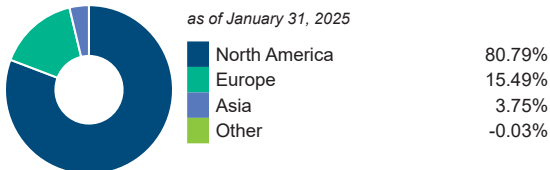
SECTOR ALLOCATION
