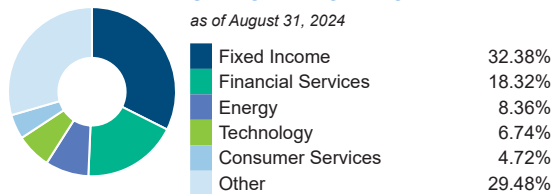
**ASSET ALLOCATION**

as of August 31, 2024



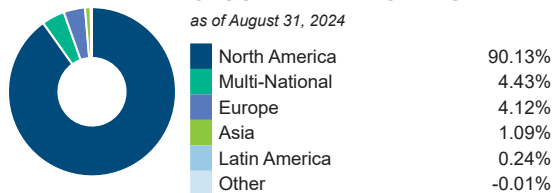
**SECTOR ALLOCATION**
