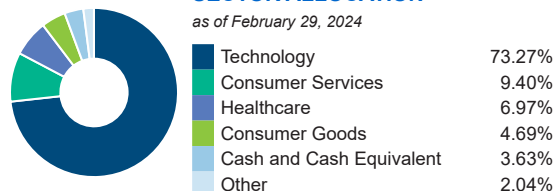
## ASSET ALLOCATION

as of February 29, 2024



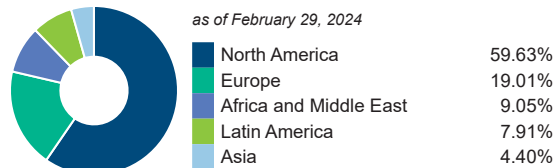
## SECTOR ALLOCATION

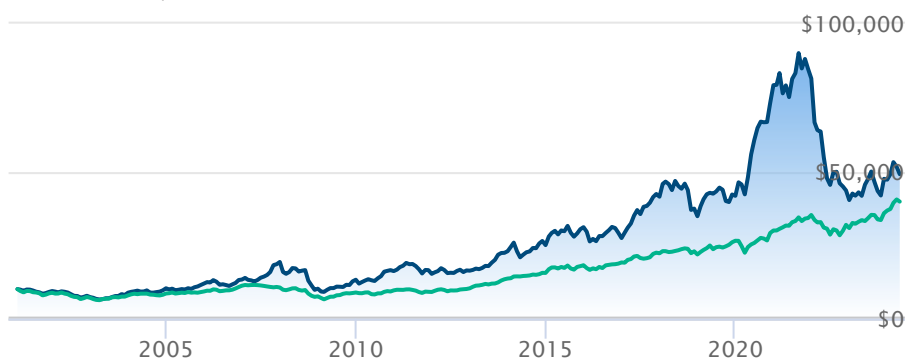
