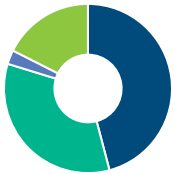

SECTOR ALLOCATION

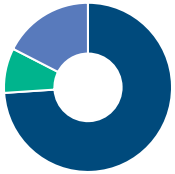

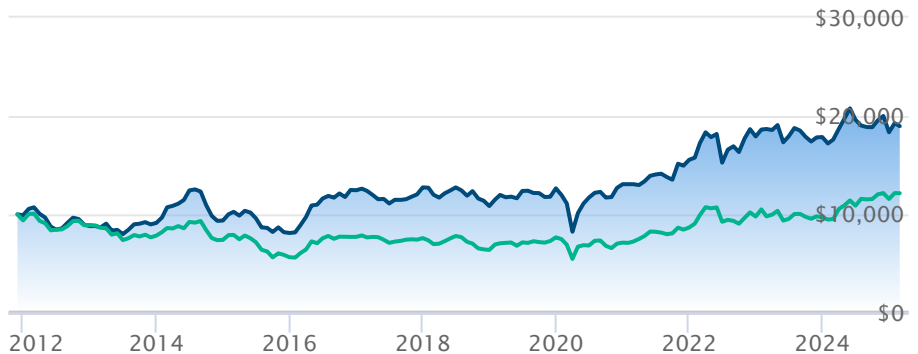
