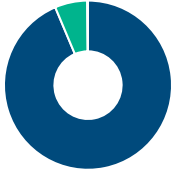

**SECTOR ALLOCATION**

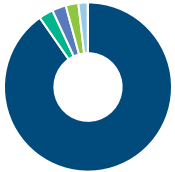
