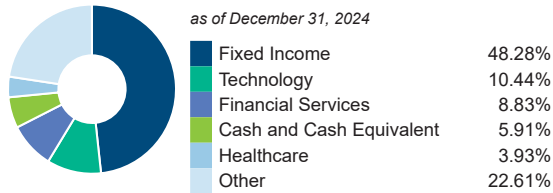
**ASSET ALLOCATION**

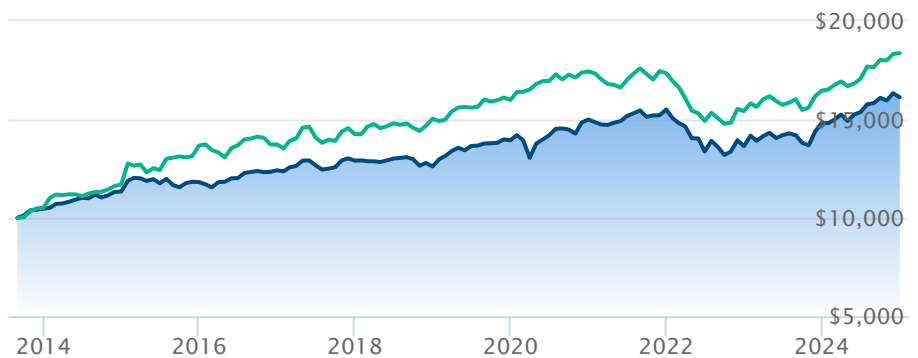
