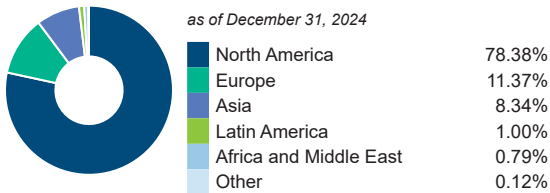
**SECTOR ALLOCATION**

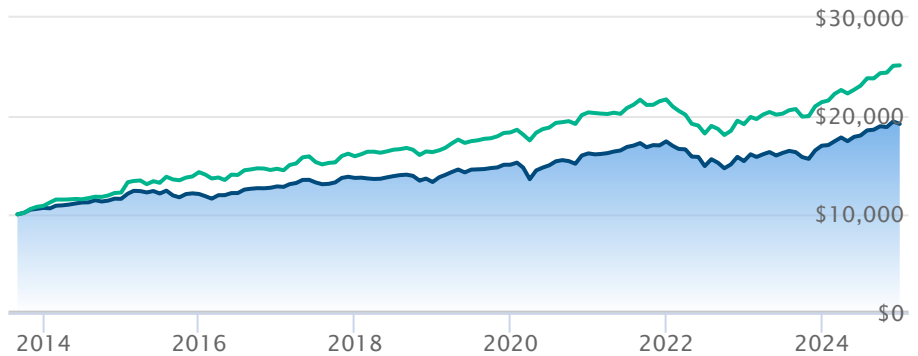
