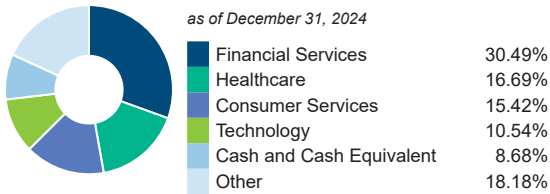
ASSET ALLOCATION

as of December 31, 2024



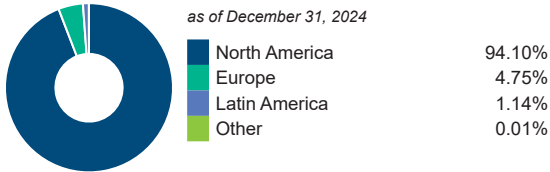
SECTOR ALLOCATION

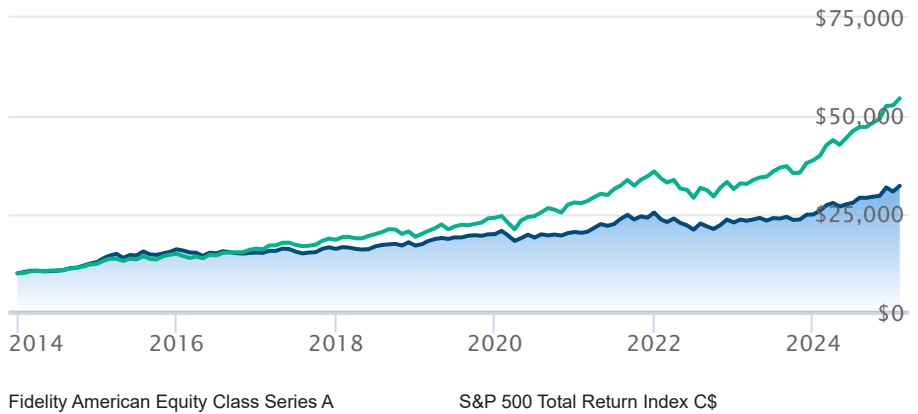
