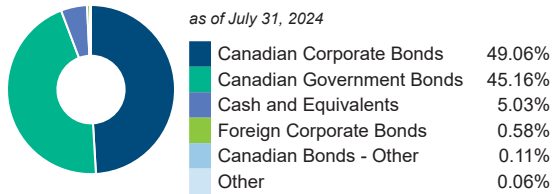

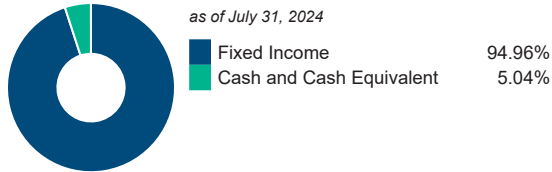
**ASSET ALLOCATION**

as of July 31, 2024



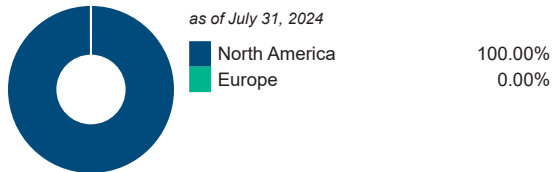
**SECTOR ALLOCATION**

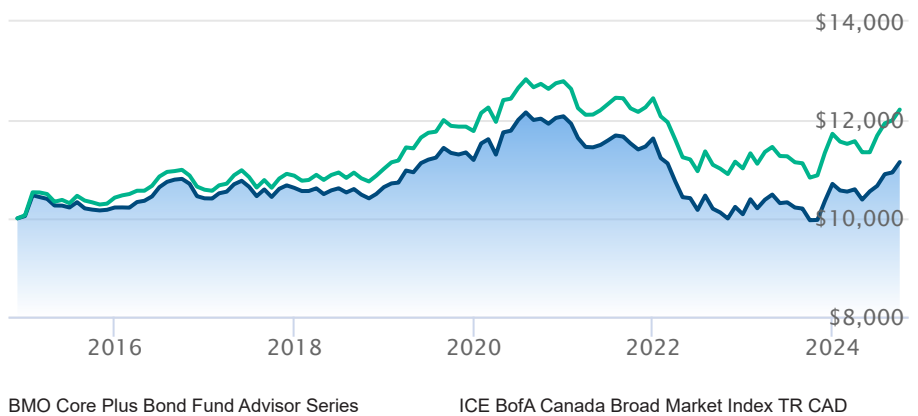
