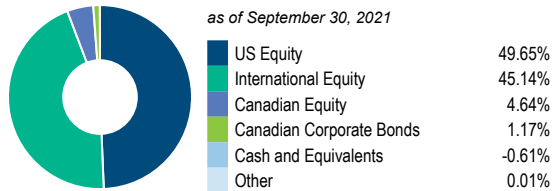

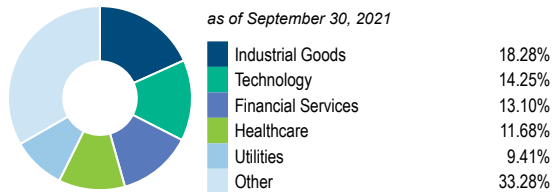
ASSET ALLOCATION

as of September 30, 2021



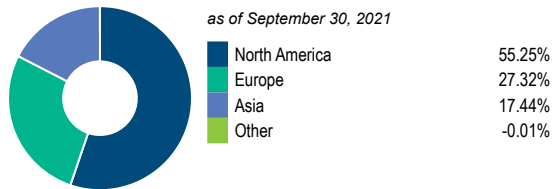
SECTOR ALLOCATION

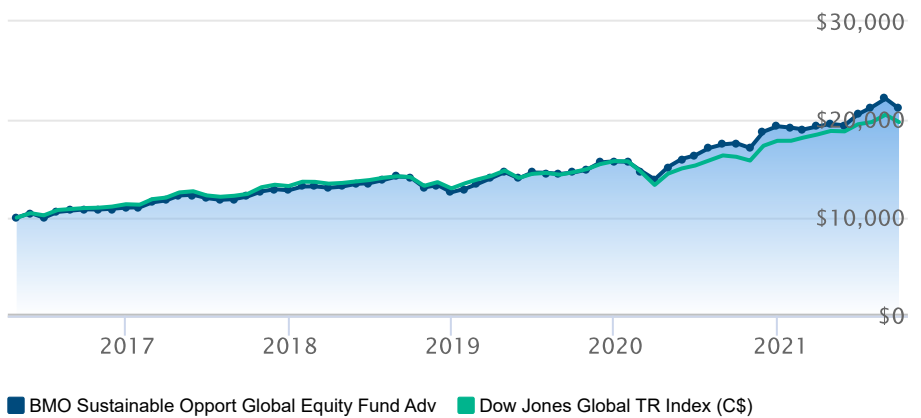
