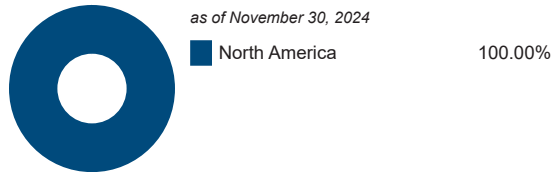
SECTOR ALLOCATION

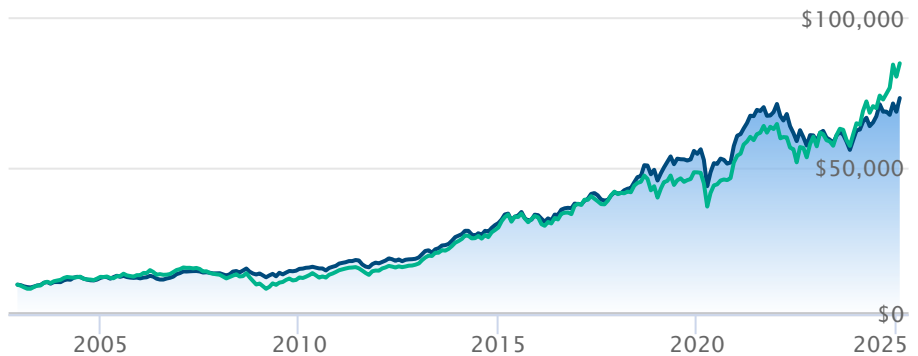
