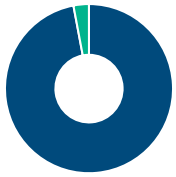
OBJECTIVE

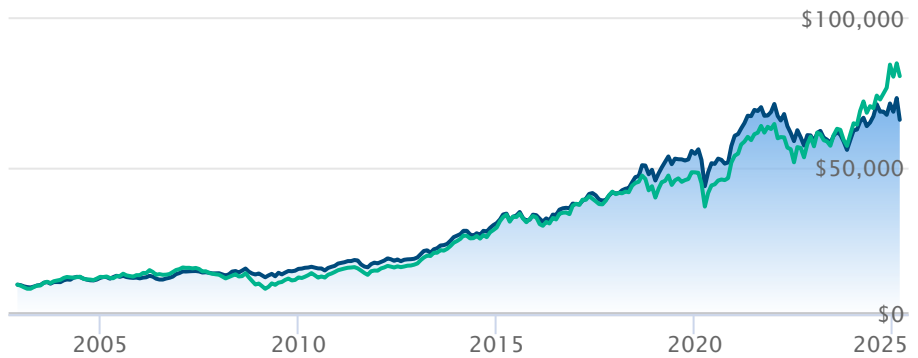
