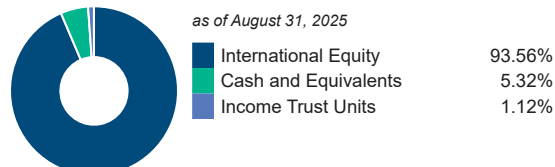

as of August 31, 2025



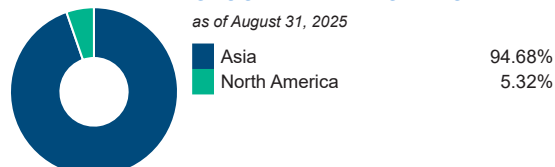
SECTOR ALLOCATION

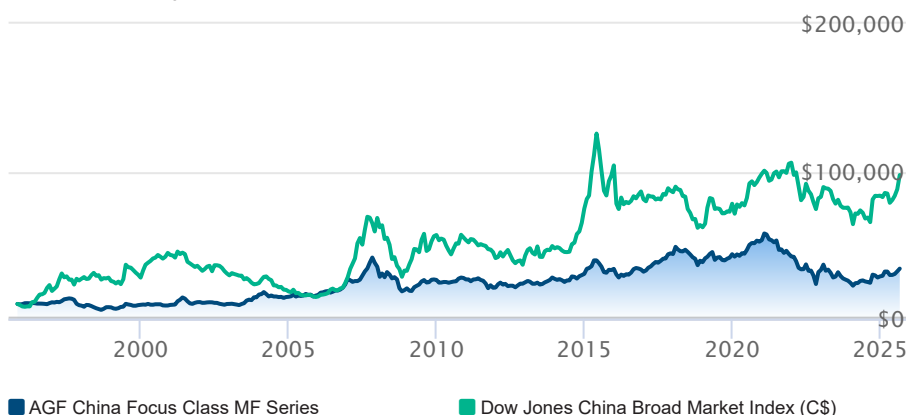
