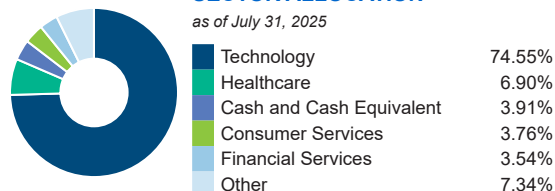
## ASSET ALLOCATION

as of July 31, 2025



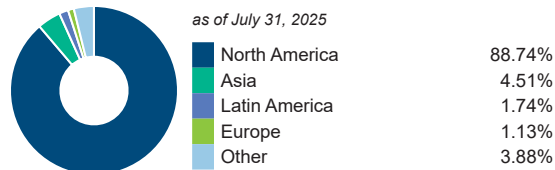
## SECTOR ALLOCATION
