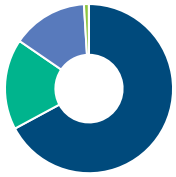

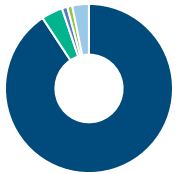

**SECTOR ALLOCATION**

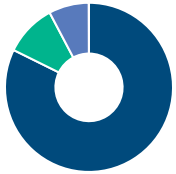
