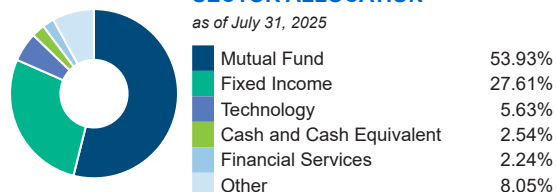
ASSET ALLOCATION

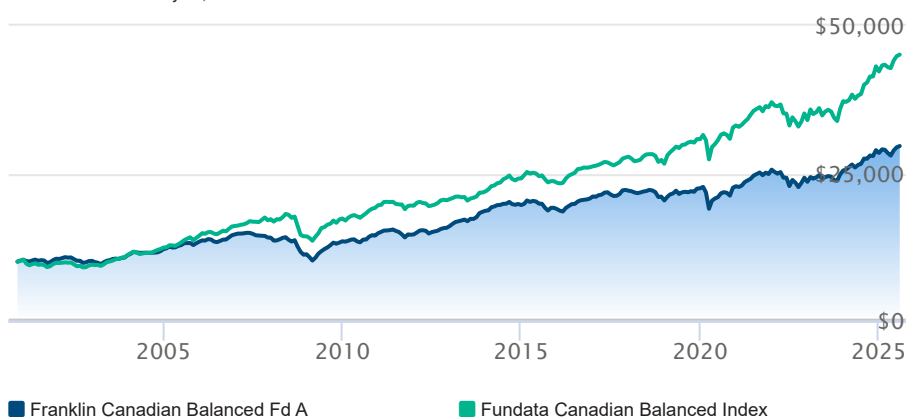
