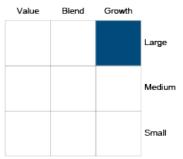
GEOGRAPHIC ALLOCATION

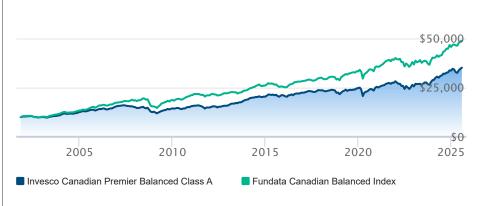
