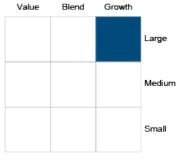


GEOGRAPHIC ALLOCATION

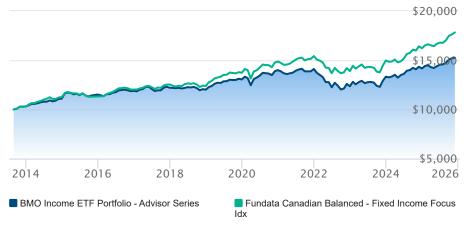
