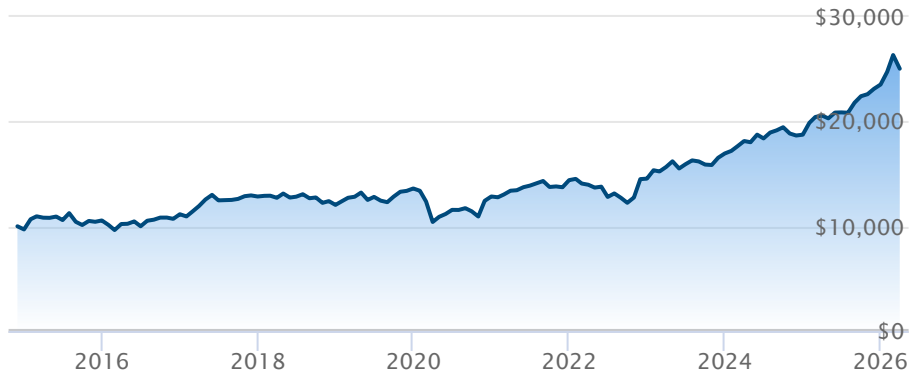

**GROWTH OF \$10,000**

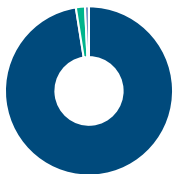
Annual values as of March 31, 2026
